BACKGROUND

On June 24, 2014, the City Council adopted Resolution 2014-41 calling a General Municipal Election for November 4, 2014.

On November 4, 2014, the Mayor and City Council election was held which included five candidates. Two candidates, incumbent Ann Nevero and Alan Galbraith, running for the Mayor's seat; three candidates, incumbent Mario Sculatti, incumbent Peter White and Paul Dohring running for the two City Council positions. On November 21, 2014, the Napa County Registrar of Voters canvassed the vote and certified the final count. Peter White and Paul Dohring were successful in their bids for Council seats for four-year terms. Alan Galbraith was elected Mayor for a two year term.

FISCAL IMPACT

The costs for the consolidation of the election are not known at this time.

RECOMMENDED ACTION

Adopt the resolution accepting the certification of the vote for Mayor and Council members.

RECITALS

- A. Regular General Municipal Election was held and conducted in the City of St. Helena, County of Napa, State of California, on Tuesday, November 4, 2014 as required by law; and
- B. At said election, in accordance with applicable law, votes were received and canvassed and the results determined; and
- C. Notice of said election was given in time, form, and manner as provided by law; candidates were nominated to fill the vacancies as provided by law; voting precincts were properly established; election officers were appointed and in all respects the election was held and conducted and the votes cast, received and canvassed and the returns made and declared in time, form, and manner as required by the provisions of the Election Code of the State of California; and

NOW THEREFORE, BE IT RESOLVED by the City Council for the City of St. Helena as follows:

- 1. The results of the General Municipal Election held on November 4, 2014 shall be entered into the record through the adoption of this resolution.
- 2. That a complete and correct copy of the results of said election as canvassed and certified by the office of John Tuteur, County Registrar of Voters, is attached "Exhibit A" and shows:
 - a. One candidate, Alan Galbraith, was elected to serve a two-year term as Mayor.
 - b. Two candidates, Paul Dohring and Peter White, were elected to serve four-year terms as Council Members.
- 3. That the City Clerk is hereby directed to provide a certified copy of this resolution to the Office of the County Registrar of Voters.


